PHASE 1 - DATA INGESTION

The data provided will be ingested into our SAR bureau software that will reduce the information using OCR, indexing, unpacking, de-duplication, search terms and filtering the data. During this process the system will break PST email files into individual emails, strip off and thread attachments, and attempt to de-duplicate documents through an algorithm hash process. At the same time, it will categorise each document according to pre-defined criteria and count how many times each document contains any of the key words specified, such as 'grievance' or 'sickness'.

PHASE 2 - BUSINESS AS USUAL

The team will analyse the remaining data set on the platform with the key objective of further reducing the page number count to be redacted. During this phase, DPP will work on the platform removing any obvious commercial and non-personal data from the final data set to be reviewed.

PHASE 3 - MANUAL REDACTION

Our SAR team will review each document in the dataset and apply redaction to:

1. Any information they believe is covered by an exemption from disclosure set out in the Data Protection Act 2018;
2. The personal data of others that is not reasonable to disclose under the circumstances and/or subject to your instructions.
3. Information that is not personal data relating to the requestor and to which they are not entitled.

At the end of the review process, we will produce two sets of documents: a set for disclosure to the requestor and a set for you containing all our highlights.
